Treasurer and Finance Chair, Mike Nichols presented the recommendations of the Finance Committee. Mike Nichols made the motion to approve all five recommendations to the General Meeting for adoption.

- 1. The Treasurer transfer the actual amounts of the Scholarship, education and Library expenses from the Mayflower Fund instead of the budgeted amounts.
- 2. The mid-year meeting of the Texas Society officers and the Colony Governors be held again. \$500 has been budgeted to defray the expenses of this meeting.
- 3. The annual contribution to the General Society be continued at \$1,620.
- 4. Budget \$250 to the Awards Committee for each award recipient to pay for the donation of a commemorative brick in the Octagon area of the Mayflower Society Garden Walkway in the name of the award recipients.

5. Mike Nichols made the motion to approve recommendation five: Increase the Annual Meeting contribution to the hosting colony to \$3,000. Regarding the fifth recommendation, Mike Nichols stated that changes to the standing rules would need to be changed and therefore 2/3 approval of this recommendation was needed.

Governor Denham separately called for each item to be discussed and a unanimous approval was directed on each recommendation.

Audit Committee Chair, Charles Prince gave the Audit Committee recommendation. The one recommendation of the Committee came in response to the expanded requirements from the IRS. Bart Henson has suggested it might be in the best interest of the Society to pursue an independent audit of our financial records in the year 2018, and begin to research the expense and requirements in calendar year 2017. This will assure integrity of the records and protect the Treasurer.

Charles Prince made the motion to approve the recommendations to pursue an independent audit of our financial records in the year 2018, and begin to research the expense and requirements in calendar year 2017 to be presented the General Meeting for adoption.

Governor Denham called for discussion and the motion was approved.

Bart Henson was unable to be at the meeting. Dwight Benson, member of the Audit Committee presented the report and recommendations.

- Move the 2016-7 year surplus of about \$7,800 to the Life Member Fund. This will help
 to make the Life Member Fund more sustainable. The Endowment Committee should
 examine the Life Member fund projections annually to insure long-term sustainability.
- 2. Change the investment mix within the Life Member fund to significantly lower the allocation to REIT funds such that the final allocation would be 25% Equities, 50% REIT and 25% Bonds by
 - a. Selling about \$27,242 worth of the REIT index fund
 - b. Selling about \$18,059 worth (all) of Total International Stock Index
 - c. Purchasing about \$13,320 worth of Short Term Investment Grade Bond Fund
 - d. Purchasing about \$39,781 of Total Stock Market Index Fund
- 3. We recommend that up to \$18,380 (4.5% of the Mayflower fund) be transferred as needed to the General Fund to assist with actual scholarship grants and education expenses. Since only \$6,636 (1.9%) was transferred in 2016-7 this permits slightly more than the desired 4.0% transfer as budget.

- 4. Periodically examine the Life Member roster with whatever tools are available (Social Security Death Index, Internet and family sources, etc.) to remove deceased life members. This will insure that we are not depleting the Life Member Fund unnecessarily by paying General Society dues for deceased Life Members.
- 5. Reinvigorate our 2020 Fund commitment, effort and communications. This should include full staffing of the 2020 Fund committee (not the 2020 committee) and clear appeals to our members to show how these supplemental funds to the existing endowment funds will enable us better to fulfill our mission by increasing the size of our state scholarships to \$5,000 and \$3,000 and increasing educational efforts. (Donations during 2016-7 of \$5,877 fell far short of the \$25,000 needed each year from 2016 to 2020 to accomplish this goal).

Dwight Benson made the motion that the recommendations of the Endowment Committee be approved by the BOA for presentation to the General Assembly.

Governor Denham called for discussion and voted on each recommendation separately. All recommendations were approved.

New Business: Mike Nichols made a motion that new officers and committee chairs be invited to attend the second BOA meeting to be held on March 25, 2017. A second was made to this motion by Prarie Counce and the motion was approved.

Governor Denham adjourned the meeting at 4:30.

Parliamentarian Appointed by Governor

As previously stated, Governor Denham announced the Treasurer's report and the reports of the Finance, Audit and Endowment Committees would be taken as a group since they all deal with the Society finances.

Mike Nichols, State Treasurer, presented the report and explained that requests made last year by the Audit, Endowment and Finance Committees had been implemented.

As of February 28, 2017, the Texas Society had \$13,965 in our Bank accounts, \$3,750 on deposit with GSMD, \$151,323 in the Life Member Fund at Vanguard, and \$410,818 in the Mayflower Endowment Fund at Vanguard, for a total of \$579,855.

Total income for the 2016-2017 fiscal year was \$61,807, compared to the budget of \$65,075. Total expenses were \$54,070 compared to the budget of \$65,075. We had a surplus of \$7,737 for the fiscal year.

Membership expenses were \$37,684, compared to the budget of \$36,602. Our Operational expenses were \$6,693, compared to the budget of \$9,770. Our Education, Library and Scholarship expenses were \$9,636 compared to the budget of \$12,620.

Historian expenses were \$3,152 compared to \$2,999 budgeted. We purchased the additional Mayflower Families books which were published for the Co-Historians, and we purchased one additional complete set of Mayflower books for our additional Co-Historian.

Treasurer expenses were \$496 compared to \$500 budgeted. Membership renewal expenses were \$1,446 compared to the budget of \$1,619.

This was the second year members were able to pay their annual dues on-line using a credit card. Nichols was pleased that 275 members paid their 2017 dues using this method.

The dues campaign went well. Four members purchased Life Memberships.

Six of our eight Colonies asked for reimbursement for Educational expenses for a total of \$3,810 of the \$4,000 budgeted.

The Library Committee spent \$1,826 compared to \$4,620 budgeted. One new library was added. Several of the anticipated new Mayflower Families books were not ready.

Life Membership Analysis was updated for the review by the Endowment Committee.

After receiving the requested financial information from the Colonies, Mike Nichols prepared and filed IRS Form 990 with the IRS for the Texas Society and all of the Colonies. He will again be asking the Colonies for their financial information in order to prepare and file our group IRS 990. We are now filing the full IRS Form 990 instead of the 990-EZ.

The books were examined by the Audit Committee on March 8, 2017.

The Finance Committee was called to report by Governor Denham. Mike Nichols, Chair, reported. The Finance Committee met on March 8 to review the finances of the Society and to prepare a recommended budget for the 2017-2018 fiscal year. Members of the Finance Committee are Mike Nichols, Chairman, Bart Henson, Dwight Benson, Michael Byrne, Prarie Counce, Judie Allen and Charles Prince.

Budgeted Membership revenue for the 2017-2018 fiscal year is \$53,385. Other income and interest is budgeted at \$0. Scholarships and Education revenue is budgeted at \$18,380. Total budgeted revenue is \$71,765.

Budgeted Membership expenses are \$46,616(65% of total expenses). Operational expenses are budgeted at \$9,270 (13% of total expenses). Scholarships and Education expenses are budgeted at \$15,380 (21% of total expenses).

Mike Nichols stated that five recommendations came from the Finance Committee and approved by the BOA for presentation to the General Assembly.

Mike Nichols made the motion to approve recommendation one: The Treasurer transfer the actual amounts of the Scholarship, education and Library expenses from the Mayflower Fund instead of the budgeted amounts.

Governor Denham called for discussion and vote. The motion was approved.

Mike Nichols made the motion to approve recommendation two: The mid-year meeting of the Texas Society officers and the Colony Governors be held again. \$500 has been budgeted to defray the expenses of this meeting.

Governor Denham called for discussion and vote. The motion was approved.

Mike Nichols made the motion to approve recommendation three: **The annual contribution to the General Society be continued at \$1,620.**

Governor Denham called for discussion and vote. The motion was approved.

Mike Nichols made the motion to approve recommendation four: **Budget \$250 to the Awards**Committee for each award recipient to pay for the donation of a commemorative brick in the

Octagon area of the Mayflower Society Garden Walkway in the name of the award recipients.

Governor Denham called for discussion and vote. The motion was approved.

Mike Nichols made the motion to approve recommendation five: Increase the Annual Meeting contribution to the hosting colony to \$3,000. Regarding the fifth recommendation, Mike Nichols stated that changes to the standing rules would need to be changed and therefore 2/3 approval of this recommendation was needed.

Governor Denham called for discussion and vote. The motion was approved unanimously.

The report of the Audit Committee was presented by Chairman Charles Prince. On Wednesday, March 8, 2017, Annual Audit of the books of the Mayflower Society in the State of Texas was conducted by the Audit Committee in the Georgetown home of Mike Nichols. All financial books, records, statements and supporting documents were reviewed. As has been the case over the prior two term of the Treasurer, all statements and accounts were in order and it was clear that careful attention had been given to the accounting during the fiscal year running

from March 1, 2016 to February 28, 2017. All accounts were found to be in good order by the Committee. An unqualified audit approval of the records and statements was given by the Committee for the excellent work committed to by Mr. Nichols. Only one recommendation came out of the meeting with the Treasurer, Finance Committee and Endowment Committee as noted in the Recommendations section below.

The Mayflower accounts continue to be maintained in QuickBooks accounting software, providing continuity that makes the Audit process very efficient. Various income, expense, transaction and asset statements were reviewed covering the fiscal year, and in comparison with the budget and prior years. Detailed spreadsheets showing historical trends by the line item and accounts were also provided and studied. The Treasurer also supplied the most recent account statements from A+ Federal Credit Union where we kept some of our Operating Account funds and Vanguard Investments where we maintain our investment accounts. All of these statements were again prepared with care and demonstrated the highest level of transparency, integrity, and great attention to detail that the Audit Committee has come to appreciate with our Treasurer. Cross checks confirmed the statements and the back-up asset account statements. These spot examinations confirmed the records were indeed accurate.

We reviewed progress against the audit recommendations from last year with the following results:

1. The one recommendation of the Committee was made in response to a recommendation of the Treasurer to change the rules requiring two signatures on all checks before they are mailed by the Treasurer. It is being recommended that proper Procedures be instituted to verify one signature for payments is working, and the Society continues to be protected.

This recommendation was implemented with much satisfaction, and greatly improved the process. It is a change that will continue to assist the parties involved with maintaining and processing the State receivables and payables.

Charles Prince made a motion that recommendations of the Audit Committee approved by the BOA for presentation to the General Assembly be approved. The one recommendation of the Committee came in response to the expanded requirements from the IRS. Bart Henson has suggested it might be in the best interest of the Society to pursue an independent audit of our financial records in the year 2018, and begin to research the expense and requirements in calendar year 2017. This will assure integrity of the records and protect the Treasurer.

Governor Denham called for discussion and vote. The motion was approved unanimously.

Chairman of the Endowment Committee, Bart Henson was not present and the report was read by committee member Dwight Benson. Members of the Endowment Committee include Bart

Henson, chairman, Dwight Benson and Treasurer, Mike Nichols. Duties of the Endowment committee come from bylaws and standing rules to:

- Supervise the Endowment assets of the Texas Mayflower Society, investing for the long term while recognizing the needs for safety of principal, annual payments required and prevention of loss of value through inflation, annually reporting to the Board of Assistants.
- Oversee the Society gifting program
- Recommend the amount to be made available to support the Educational and Historical activities of the Texas Society.

The Endowment Committee met on March 19, 2016 at the home of the Treasurer Mike Nichols who had prepared records for our consideration. Endowment Recommendations to the Board of Assistants last year had been followed and implemented. Total investments in all funds increased in value over the past year by \$84,000 or 17% to \$579,856 primarily because of market valuation growth. Since 2007 (10 year period), investments have grown in value by 85% or an average annual increase of 6.35% despite continued pulls from the accounts for Life Member dues and scholarship/education expenditures.

Recommendations (in bold font) to the Board of Assistants and the Membership include:

- 3. We recommend that up to \$18,380 (4.5% of the Mayflower fund) be transferred as needed to the General Fund to assist with actual scholarship grants and education expenses. Since only \$6,636 (1.9%) was transferred in 2016-7 this permits slightly more than the desired 4.0% transfer as budget.
- 4. Periodically examine the Life Member roster with whatever tools are available (Social Security Death Index, Internet and family sources, etc.) to remove deceased life

members. This will insure that we are not depleting the Life Member Fund unnecessarily by paying General Society dues for deceased Life Members.

5. Reinvigorate our 2020 Fund commitment, effort and communications. This should include full staffing of the 2020 Fund committee (not the 2020 committee) and clear appeals to our members to show how these supplemental funds to the existing endowment funds will enable us better to fulfill our mission by increasing the size of our state scholarships to \$5,000 and \$3,000 and increasing educational efforts. (Donations during 2016-7 of \$5,877 fell far short of the \$25,000 needed each year from 2016 to 2020 to accomplish this goal).

Dwight Benson made the motion that the recommendations of the Endowment Committee approved by the BOA for presentation to the General Assembly be approved.

Governor Denham called for discussion and voted on each recommendation separately. All recommendations were approved.

The next order of business was the election of the Nomination Committee Chair. Mike Nichols nominated Prarie Counce. Leah Davis seconded the motion. No other nominations were made and Prarie Counce was elected as the 2017-2019 Nominating Committee Chair.

The selection of Deputy Governor General and Assistant General to represent the Texas Society in Plymouth was opened for nominations. Michael Byrne made the motion to nominate Mike Nichols for Deputy Governor General and Judie Allen for Assistant General. No other nominations were made and a vote was taken and approved.

The Texas Society, based on membership will be allowed at least twenty-five delegates to the 2017 General Congress in Plymouth, Massachusetts in September. Governor Denham asked for names of those interested in serving as delegates. A motion was made by Mike Nichols that we approve the following list of delegates and a second was made by Barbara Lewandowski. The motion was approved.

It has been a pleasure to serve as Governor for the past two years. I have enjoyed visiting Colonies around the state. I wish the new Governor success during the upcoming term. Thanks to all that have served as officers and committee members during my term.

REPORT OF DEPUTY GOVERNOR: Lorie Holbrooks No Report.

REPORT OF CORRESPONDING SECRETARY: Prarie Counce

Membership count consisting of regular and life members as of March 10, 2017, was 1,256 members.

The Corresponding Secretary communicates regularly with the office of the Historian General reporting deaths, name changes, address changes, resignations, dropped members, reinstated members, transfers-in, transfers-out and dual memberships.

The Corresponding Secretary prepared an Annual Report for the Texas Society at the end of 2016 and submitted it to the Secretary General and required State Officers.

The Corresponding Secretary submits an end-of-the-month report to the Board of Assistants/Directors reporting database changes.

Certificates along with congratulatory letters were sent to four (4) new Life Members since the last annual meeting (2016).

The Corresponding Secretary communicates with members and potential members as the opportunity arises or is requested by others.

The Corresponding Secretary works closely with the Treasurer, Historians, and the Governor of the State Society, and appreciates their help and guidance.

REPORT OF RECORDING SECRETARY: Judie Allen

Unable to attend last year's meeting due to health and family issues, I would like to give many thanks to Linda Hill for serving as Recording Secretary at the 2016 Annual Meeting. Also, I give many thanks to Linda Hill and Prarie Counce for all of their guidance and friendship preparing for this year.

REPORT OF TREASURER: Mike Nichols

The requests made last year by the Audit, Endowment and Finance Committees have been implemented.

As of February 28, 2017, the Texas Society had \$13,965 in our Bank accounts, \$3,750 on deposit with GSMD, \$151,323 in the Life Member Fund at Vanguard, and \$410,818 in the Mayflower Endowment Fund at Vanguard, for a total of \$579,855.

Total income for the 2016-2017 fiscal year was \$61,807, compared to the budget of \$65,075. Total expenses were \$54,070 compared to the budget of \$65,075. We had a surplus of \$7,737 for the fiscal year.

Membership expenses were \$37,684, compared to the budget of \$36,602. Our Operational expenses were \$6,693, compared to the budget of \$9,770. Our Education, Library and Scholarship expenses were \$9,636 compared to the budget of \$12,620.

Historian expenses were \$3,152 compared to \$2,999 budgeted. We purchased the additional Mayflower Families books which were published for the Co-Historians, and we purchased one additional complete set of Mayflower books for our additional Co-Historian.

Treasurer expenses were \$496 compared to \$500 budgeted. Membership renewal expenses were \$1,446 compared to the budget of \$1,619.

This was the second year members were able to pay their annual dues on-line using a credit card. I am pleased that 275 members paid their 2017 dues using this method.

The dues campaign went well. Four members purchased Life Memberships.

Six of our eight Colonies asked for reimbursement for Educational expenses for a total of \$3,810 of the \$4,000 budgeted.

The Library Committee spent \$1,826 compared to \$4,620 budgeted. One new library was added. Several of the anticipated new Mayflower Families books were not ready.

I updated our Life Membership Analysis for the review by the Endowment Committee.



This has been an extremely busy year for the historians. For the calendar year 2016, we had 102 new members approved and 24 supplemental applications approved. The 2016 General Board of Assistants meeting held at the Columbia Club in Indianapolis, Indiana on September 8-11 was very informative. Our Deputy Governor General, Mike Nichols was quite impressive to all societies as he was so well informed on technological issues, finance issues and by-laws.

Governor General, Lea Filson, hosted listen-only conference calls for GSMD officers and members. These calls were held quarterly in order to update officers on news and Society business. These were very useful to keeping informed of GSOMD business.

COMMITTEE REPORTS

REPORT OF AUDIT COMMITTEE: Charles Prince

Summary

On Wednesday, March 8, 2017, Annual Audit of the books of the Mayflower Society in the State of Texas was conducted by the Audit Committee in the Georgetown home of Mike Nichols. All financial books, records, statements and supporting documents were reviewed. As has been the case over the prior two term of the Treasurer, all statements and accounts were in order and it was clear that careful attention had been given to the accounting during the fiscal year running from March 1, 2016 to February 28, 2017. All accounts were found to be in good order by the Committee. An unqualified audit approval of the records and statements was given by the Committee for the excellent work committed to by Mr. Nichols. Only one recommendation came out of the meeting with the Treasurer, Finance Committee and Endowment Committee as noted in the Recommendations section below.

Discussion

The Mayflower accounts continue to be maintained in QuickBooks accounting software, providing continuity that makes the Audit process very efficient. Various income, expense, transaction and asset statements were reviewed covering the fiscal year, and in comparison with the budget and prior years. Detailed spreadsheets showing historical trends by the line item and accounts were also provided and studied. The Treasurer also supplied the most recent account statements from A+ Federal Credit Union where we kept some of our Operating

Account funds and Vanguard Investments where we maintain our investment accounts. All of these statements were again prepared with care and demonstrated the highest level of transparency, integrity, and great attention to detail that the Audit Committee has come to appreciate with our Treasurer. Cross checks confirmed the statements and the back-up asset account statements. These spot examinations confirmed the records were indeed accurate.

We reviewed progress against the audit recommendations from last year with the following results:

1. The one recommendation of the Committee was made in response to a recommendation of the Treasurer to change the rules requiring two signatures on all checks before they are mailed by the Treasurer. It is being recommended that proper Procedures be instituted to verify one signature for payments is working, and the Society continues to be protected.

This recommendation was implemented with much satisfaction, and greatly improved the process. It is a change that will continue to assist the parties involved with maintaining and processing the State receivables and payables.

Recommendations

1. The one recommendation of the Committee came in response to the expanded requirements from the IRS. Bart Henson has suggested it might be in the best interest of the Society to pursue an independent audit of our financial records in the year 2018, and begin to research the expense and requirements in calendar year 2017. This will assure integrity of the records and protect the Treasurer.

REPORT OF ENDOWMENT FUND: Bart Henson

Duties of the Endowment committee come from our bylaws and standing rules to:

- Supervise the Endowment assets of the Texas Mayflower Society, investing for the long term while recognizing the needs for safety of principal, annual payments required and prevention of loss of value through inflation, annually reporting to the Board of Assistants.
- Oversee the Society gifting program

 Recommend the amount to be made available to support the Educational and Historical activities of the Texas Society.

The Endowment Committee met on March 19, 2016 at the home of the Treasurer Mike Nichols who had prepared excellent records for our consideration.

Our Endowment Recommendations to the Board of Assistants last year had been followed/implemented.

Our total investments in all funds increased in value over the past year by \$84,000 or 17% to \$579,856 primarily because of market valuation growth. Since 2007 (10 year period), our investments have grown in value by 85% or an average annual increase of 6.35% despite continued pulls from the accounts for Life Member dues and scholarship/education expenditures.


Recommendations (in bold font) to the Board of Assistants and the Membership include:

- Move the 2016-7 year surplus of about \$7,800 to the Life Member Fund. This will help
 to make the Life Member Fund more sustainable. The Endowment Committee should
 examine the Life Member fund projections annually to insure long-term sustainability.
- 2. Change the investment mix within the Life Member fund to significantly lower the allocation to REIT funds such that the final allocation would be 25% Equities, 50% REIT and 25% Bonds by
 - a. Selling about \$27,242 worth of the REIT index fund
 - b. Selling about \$18,059 worth (all) of Total International Stock Index
 - c. Purchasing about \$13,320 worth of Short Term Investment Grade Bond Fund
 - d. Purchasing about \$39,781 of Total Stock Market Index Fund
- 3. We recommend that up to \$18,380 (4.5% of the Mayflower fund) be transferred as needed to the General Fund to assist with actual scholarship grants and education expenses. Since only \$6,636 (1.9%) was transferred in 2016-7 this permits slightly more than the desired 4.0% transfer as budget.
- 4. Periodically examine the Life Member roster with whatever tools are available (Social Security Death Index, Internet and family sources, etc.) to remove deceased life members. This will insure that we are not depleting the Life Member Fund unnecessarily by paying General Society dues for deceased Life Members.
- 5. Reinvigorate our 2020 Fund commitment, effort and communications. This should include full staffing of the 2020 Fund committee (not the 2020 committee) and clear appeals to our members to show how these supplemental funds to the existing endowment funds will enable us better to fulfill our mission by increasing the size of our state scholarships to \$5,000 and \$3,000 and increasing educational efforts. (Donations during 2016-7 of \$5,877 fell far short of the \$25,000 needed each year from 2016 to 2020 to accomplish this goal).

This following table shows what our asset mix of our funds in total looks like at the end of the 2016 fiscal year and what it will look like after the recommended asset switches shown in Recommendations 1 and 2 above.

Report of the Finance Committee: Mike Nichols

The Finance Committee met on March 8 to review the finances of the Society and to prepare a recommended budget for the 2017-2018 fiscal year.

Budgeted Membership revenue for the 2017-2018 fiscal year is \$53,385. Other income and interest is budgeted at \$0. Scholarships and Education revenue is budgeted at \$18,380. Total budgeted revenue is \$71,765.

Budgeted Membership expenses are \$46,616(65% of total expenses). Operational expenses are budgeted at \$9,270 (13% of total expenses). Scholarships and Education expenses are budgeted at \$15,380 (21% of total expenses).

The Finance Committee recommends that:

- The Treasurer transfer the actual amounts of the Scholarship, education and Library expenses from the Mayflower Fund instead of the budgeted amounts.
- The mid-year meeting of the Texas Society officers and the Colony Governors be held again. \$500 has been budgeted to defray the expenses of this meeting.
- The annual contribution to the General Society be continued at \$1,620.
- Budget \$250 to the Awards Committee for each award recipient to pay for the donation of a commemorative brick in the Octagon area of the Mayflower Society Garden Walkway in the name of the award recipients.
- Increase the Annual Meeting contribution to the hosting colony to \$3,000.
