Disposition of Motions from the 2015 Annual Meetings

The first Board of Assistants meeting convened on Friday, March 27th at 4 PM. Both the sitting Governor and Deputy Governor were unable to attend. Governor Carol Scarborough wished that Linda Hill, Recording Secretary, serve as Governor pro tem and chair the meeting and that Prarie Counce, Corresponding Secretary, serve as Recording Secretary pro tem. This action was approved. Housekeeping motions relating to the approval of the minutes of the 2014 minutes, the appointment of a time keeper and the tellers for the 2015 Annual meeting were presented and approved. The results of email votes by the Board of Assistants since the last meeting in March 2014 were approved. The motions were to approve Mike Nichols as Acting Assistant General for the 2014 GSMD Annual Meeting, approve funds for equipment for the Co-Historians not included in the 2014 budget and approve the appointment of Judie Allen to serve as acting Assistant Governor until her election at the GSMD meeting in fall 2015.

The recommendations of the Treasurer, Finance Committee Chairman, Endowment Committee Chairman, and Audit Committee were presented and approved. A Policy Committee shall be created and that committee will prepare a Whistle Blower Policy and a Conflict of Interest Policy. The Duties of the Officers in the Bylaws shall be changed to ensure compliance with the approved policies of the TXSOMD and these approved policies shall be added to the Yearbook. The Nominating Committee shall canvas the colonies and identify a candidate for Treasurer who shall serve on the Finance Committee. Any surplus at the end of the 2015-2016 fiscal year shall be transferred to the Life Membership fund. A mid-year meeting of the Texas Society officers and the Colony Governors shall be held with \$800 being budgeted for expenses. A second scholarship in the amount of \$1,000 shall be awarded and added to the budget. Six items specifying transfers between the various Endowment funds to balance the funds and reduce risk and exposure were presented and approved. new vendor to provide credit cards for the Historians shall be researched. The Education Committee should provide a resource list for the use of Colony Education funds to encourage colonies to use the allocations. Education funds not used by the colonies by December 31st shall be forfeited and available for use by other colonies. Competive bids shall be obtained from vendors for the pricing of the newsletters and Yearbook. The Historians shall submit receipts from their debit cards to the Treasurer quarterly. Mary Eck, Scholarship Chairman, moved that the eligibility statement for scholarship applicants be reworded and that the Scholarship Chairman be moved from "Other Committees" and be added to "Standing Committees". The motion to reword the eligibility statement was approved. The change from Other Committees to Standing Committees requires a Bylaws change and was referred to the Bylaws Committee for action. The meeting adjourned at 6:10 P.M.

The second Board of Assistants meeting convened on Saturday, March 28th at 3:30 PM. Rick Denham, Governor Elect, presented his Committee Chairman appointments. All were approved. A motion that the TXSOMD destroy in a secure manner all paper applications and supporting documents by year end 2015 was approved. A new scholarship eligibility statement was moved and approved as follows "The graduate may hold a Texas Junior Mayflower membership number or a parent or grandparent must be a currently verifiable member in good standing of the Texas Society of Mayflower Descendants." A motion to Eliminate the Annual Meeting Liaison position from the Standing Rules was out of order and referred to the Bylaws Committee. The second Board of Assistants meeting adjourned at 4:25 PM.

Annual Meeting Motions Continued

The 2015 Annual Meeting of the Texas Society of Mayflower Descendants convened at 9:21 on March 28th in Houston. Housekeeping motions to adopt the program, approve the standing rules for the meeting, appoint three members of the body to read and approve the 2015 minutes, and the appointment of timekeepers and tellers were approved. The recommendations from the Treasurer, Finance Committee, Endowment Committee, and the audit committee presented during the First Board of Assistants meeting were moved for endorsement. All were approved. The bylaws amendments as printed in the Winter newsletter were moved and approved with the exception of eliminating the office of Surgeon. This proposed amendment was withdrawn because it would conflict with the General Society bylaws. The slate of officers as presented in the Winter Newsletter was elected, as there were no nominations from the floor. Leah Davis was nominated to be Chairman of the Nominating Committee; this was approved. A motion to approve Judie Allen as Assistant General Nominee was made and approved. The business portion of the meeting recessed at 3:20 P.M.

Linda Hill, Governor pro tem, called the banquet meeting to order at 7:00 P.M. Lea Filson, Governor General, spoke about "The Mayflower Society in the 21st Century, It's More Important Now than Ever." The Annual Award of Recognition was presented to Charles Prince, Houston Colony, and Michael Byrne, San Antonio Colony for their contributions to the State Society and to their colonies by Judie Allen representing the Awards Committee. Catherine Prince Caprio was awarded the 2015 state Mayflower scholarship. The new officers were introduced and installed by Governor General Filson. The Governor's neck medallion and gavel were presented to new Governor Rick Denham. Prarie Counce, Corresponding Secretary, read the Courtesy Resolutions and Michael Byrne issued the invitation to the 2016 Annual Meeting to be held in San Antonio. Governor Denham adjourned the meeting at 9:30 P.M.
